### **ADDITIONAL FEES**

#### **Farmington Valley Health District Temporary Food Permit Application Fee: \$50 (Required)**

Those not carrying annual permits through the FVHD for food service will be required to submit a temporary food service permit application and \$50 fee (payable to FVHD) for each event with the exception of the five Talcott Mountain Music Festival Concerts, which would be considered part of one all-encompassing event permit. Completed application and payment of fee will be due at time of vendor agreement execution.

#### **Support Services (Optional)**

For those vendors who are not fully self-contained, additional support services may be made available at select events for an additional fee. Payment for any additional services requested will be due at the time of vendor agreement execution.
